# MEMBERSHIP PURCHASE AGREEMENT

This Membership Purchase Agreement (this “Agreement”) is entered into as of the date listed below by and between the undersigned individual or business entity (the “Member”) and The Resort at Tapatio Springs.

## **I Agreement to Purchase**

The Member hereby agrees to purchase the membership in the Club described on Exhibit A attached hereto (the “Membership”) on the terms, conditions and specifications described herein and subject to the Bylaws of the Club, as such may be amended from time to time (the “Bylaws”), and the Rules and Regulations of the Club, as such may be amended from time to time (the “Rules and Regulations”).

## **II Receipt & Understanding of Bylaws & Rules and Regulations**

The Member acknowledges receipt of a copy of the Bylaws in effect on the date hereof and a copy of the most current Rules and Regulations and agrees to be bound by all of the respective terms and conditions of each. Additionally, the Member acknowledges having inspected the Bylaws and the Rules and Regulations and obtained all information necessary to make the decision to purchase a Membership. The Member hereby acknowledges that the Bylaws and the Rules and Regulations are subject to change pursuant to the terms thereof.

## **III Value and Transferability of Memberships**

The Member hereby agrees that the payments made hereto or pursuant to this Agreement are for the purchase of the Membership and the rights associated therewith and that neither this Agreement nor the Membership conveys any right, title, or interest in specific asset of the Club or any of its facilities or property. All memberships in the Club are non-transferable.

## **IV Forfeiture of Membership**

The Club reserves the right to terminate the Membership at any time should the Member fail to comply with any of the terms and conditions set forth in this Agreement, the Bylaws, or the Rules and Regulations. It is further understood that I may resign from the Club by giving thirty (30) days advance written notice to the Club and by paying any dues or other charges for which I may be liable, and shall not thereafter be subject to any further dues or other charges, except for dues payable while the Membership is on the resigned list for transfer, as provided in the Bylaws.

## **V Membership Category and Initiation Fee**

The Member hereby agrees to pay to the Club in accordance with the terms described on Exhibit A the amounts reflected thereon for the Membership described thereon.

**VI Membership Deposit**

The Membership Deposit for the designated membership is \$\_\_\_\_\_. The Membership Deposit will serve as a guarantee for the payment of all dues and charges applicable to this Membership. I may not offset dues and charges against the Membership Deposit.

**VII Monthly Dues**

The Club shall determine a payment amount that the Member agrees to make payable in advance on a monthly basis (the "Dues"). The Member agrees to make such monthly payment of Dues pursuant to the conditions set forth in the Bylaws. The Club and the Member agree that, subject to the Bylaws, the Club may increase or decrease Dues at any time. Additionally, the Club and the Member understand and agree that the payment of Dues does not cover all services and privileges offered by the Club. The Member agrees that payment for those services and privileges not covered by the monthly payment of Dues, but provided by the Club upon the request of the Member, will be made in accordance with the payment of other Club charges as specified in the Bylaws.

**VIII Effective Date**

The Club and the Member agree that the Member's obligation to purchase a Membership pursuant to the Agreement shall be effective upon its execution by both an authorized representative of the Club and the Member; however, no Certificate of Membership shall be issued until such time as the Initiation Fee specified above is received in good funds into the Club's bank account. Upon payment of such fee, the Member shall be granted a membership in the Club of the type listed on Exhibit A, and the Member shall have the rights and privileges ascribed thereto in the Bylaws. For purposes related to the Membership, the Member's Membership Anniversary Date shall be the date hereof.
